The Director, Department of Tourism, Kerala as per letter referred (4) has directed the District Collector, Thrissur to take necessary steps to call for a fresh panel so as to furnish a proposal to Government for filling up the post of Secretary, District Tourism Promotion Council, Thrissur on the basis of deputation, in tune with the existing rules/guidelines, issued by the Government from time to time.

The qualification for the post of Secretary, District Tourism Promotion Council, Thrissur is given below :

1. The applicant must be an employee not below the rank of a Gazetted officer in State/Quasi-Government offices in Thrissur district.
2. The desirable qualification for the post is that the applicant must be a Graduate/Diploma in Tourism, MBA/B Tech (Civil) with 03 years experience in the Tourism sector.
3. Age limit will be between 22 to 50 years.

The candidate selected through an interview will be posted on the basis of deputation for a period of 01 year initially. The period of appointment may be extended for a term of 02 more years, as per the usual terms and conditions of deputation, if the service of the appointee is satisfactory.

The person so appointed as Secretary, District Tourism Promotion Council, Thrissur is eligible to get remuneration in accordance with terms and conditions governing the deputation.

The applications accompanied by bio-data and copies of testimonials of eligible candidates should be forwarded to the District Collector, Thrissur through proper channel. However, it is permitted to send advance copies of application to the District Collector directly in cases where delay in forwarding applications through proper channel is expected. The selected candidate will have to produce No Objection Certificate from the appointing authority of the parent department. The last date of receipt of application at the office of the District Collector, Thrissur is 30.09.2016.
